### Jun-Toting Teachers By Natalie

There has been a big controversy in a little town called Harrold, Texas. Harrold is in Wilbarger County, which is a huge county known for high crime rates in some areas. In Harrold there is a school, kindergarten through 12th grade, with about 50 teachers and 110 students called Harrold Independent School District. On October 2<sup>nd</sup>, this school had a unanimous vote to let teachers carry concealed guns to protect themselves and the students.

In phone interview, Superintendent David Theweatt said his staff carries weapons because of all the recent school shootings like

the ones at Virginia Tech and the Amish School House in Pennsylvania. His concern for school got higher when a house that produced drugs was shut down about 50 feet from the school.

Theweatt was worried about crime after this event and the nearest police department is about 17 miles away which is about a 30 minute drive without any weather or traffic



conditions. So Thweatt took matters into his own hands and got a security consultant to help train teachers to use their weapons and maintain security. He also got special bullets that won't

According to the New York Times some people think no matter how much training there is just too many things could happen with a gun in the classroom and other people think that it's no place for a teacher to decide life or death for someone.



National Gun laws have said that there can be no weapons on campuses, but the government has made exceptions for school boards allowing people in higher education to carry concealed hand guns. Harrold is the only secondary school to take advantage of this exception.

For the teachers to carry guns, they had to go into special crisis management classes and get a Texas gun license. According to a resident, Coy Cato, it's a good way to protect their children. The school discussed other options like mace or taser guns, but none were found suitable. Mr. Theweatt voiced that the school thought about peace officers, but when he found out Columbine had an officer who ran out of the building when the gunmen came, the

school overrode the option of a peace officer. HISD thinks the media is overlooking these discussions.

According to Mr. Theweatt, there have been a few parents who voiced their opposing opinions. One parent chose to withdraw her children from the school. The resident was basically told to deal with this new policy or find a new school district, she told the New York Times.

Mr. Theweatt says his school is "safer than a bank." HISD is equipped with panic buttons, electronic doors, and cameras. Theweatt's hope is that these measures will prevent any type of situation happening at Harrold Independent School District.

from anti-gay Americans, who are quite prevalent even in today's society. Fred Phelps of the Westboro Baptist Church and his Christian congregation, who many other legitimate, accepting Christians, such as Unitarian Universalists, refuse to identify with, have protested many funerals of gay and lesbian people throughout Massachusetts, hoisting signs that display highly offensive messages towards gays.


Another example of widespread discrimination and a violation of rights for gay, lesbian, bisexual, and transgender, (GLBT) individuals is the US Military's "Don't Ask, Don't Tell" policy. Many dedicated officers in service have been prosecuted for having "a propensity or intent to engage in gay acts" under US code, Title 10, Subtitle A, Part II, Chapter 37, Section 654. According to the US Code online governmental database, "the prohibition against gay conduct is a longstanding element of military law that continues to be necessary in the unique circumstances of military service." Serving in the armed forces is not a constitutional right; the government is legally allowed to deny gays of their ability to fight for their country.

The United States of America's government does not allow gays to legally marry, nor are they able to gain the same health care benefits which heterosexual couples get. They can have unsanctioned marriages that are not legally recognized in any states except for California and Massachusetts, which have now become havens in which gays thrive.

One source of discrimination is derived from the beliefs of Fundamentalist Christians who have opposed gays because they believe that their God does not approve of same-sex relationships. They cite the Old Testament of the Christian Bible. The story of Sodom and Gomorrah explains how a group of gays were punished by the Christian God for their "sins." America was founded by Anglo-Saxon European Christians who incorporated their religious ideology into the basis of

their government. There has been quite a lot of separation between church and state since the initial foundation of the United States of America, but many of the beliefs remain.

Christians aren't the only group of people known for having certain extremist individuals within their group that hate gays. People with some sort of prejudice can be found in nearly any group, regardless of whether it is religious or not. There are some people who are just plain xenophobic and dislike gays because they think it's abnormal and don't want to accept it.

If one were to look at the rights of gays in other countries, they would see varying views. Certain areas in the Middle East punish gays with execution, whereas other places such as parts of Europe treat gay people no differently than anyone else, giving them equal rights. According to The Chicago Free Press, a local gay newspaper, the best places for gays to live include Sydney, Mykonos, Paris, Barcelona, Copenhagen, and Amsterdam. They also state that the worst places for gays to reside are Saudi Arabia, Nigeria, Iran, Jamaica, and Afghanistan. There are also many parts of the world, where

despite having the same legal rights as others, gays are still treated worse. This is discrimination and not a denial of rights by the governing power, but it is still significant.

The ever-growing popularity of current senator and democratic presidential candidate Barack Obama means he could potentially become the president and reform numerous things, including the rights of gays. Presidents have seemingly little power when it comes to matters such as this, which are more suited for congress, but some believe they can have a positive influence on such outcomes. However, David Crary, a writer for the Associated Press, seems to think otherwise. He has claimed that "neither John McCain nor Barack Obama [seem] eager to push the issue high on their campaign agendas."

Despite economic woes which the US is currently facing, there may still be focus on other issues. New legislature might be passed to cut down on discrimination and ensure that everyone is given the same rights.

# LOCAL Who Handles a Crisis?

At the Orthogenic School, you may happen to see someone running out of a classroom becoming very upset. Some students may calm quickly, but, on the other hand, some students might go to plan B: a crisis. Every school has their own different way of handling a crisis. The Orthogenic School has a job that handles crisis and it is called coverage. Lisa, De Marco, Michael, Warren, Paul, Art, and Sandy all work as coverage for the Orthogenic School. Coverage is one of the most important jobs throughout the school.

Before a staff member is hired they must meet some requirements like "Supreme awesomeness!" says Michael. "You have to have a masters degree and five years of experience in residential, you have to have a proven track record [that] shows that you can effectively interact with difficult students," said Art. Also "coverage must have a willingness to work in a highly demanding work situation requiring both flexibility [and] innovativeness," says Paul. It also helps if the person possesses "cultural competency," he explains.

When coverage is not handling a crisis, they "ensure that the Daily routine is maintained. We ensure that everyone, staff/students, are safe and

feel safe," Sandy said. They must also "assist staff in decision making/alternatives of handling situations before a crisis develops." Said Lisa.

When you are in your dorm you may hear a counselor ask over the walkie, "Can coverage please come to the dorm?" Coverage doesn't always come to the dorm for bad reasons, they come to check in, see if the dorm has a walkie, see if everything is fine, or to bring something to the dorm.

The job has some perks. Lisa wanted to let us know that "talking with and getting to know all of the young people on an individual basis," was one of her favorite parts of the job. Sandy and De Marco had similar answers. "Getting to know the students," and "working with the students and helping them when needed," were what they enjoy.

When students go on home visits, they are told that when they have an emergency, they can call the coverage phone. Sometimes the coverage phone is not on. So when asked, do you always have the coverage phone on and charged? Paul said, "The question depends on the day. If it is a day when the secretaries are in the office, coverage picks the phone up in the front office at 5 PM or when the

secretaries leave. On the weekends and at night, coverage should have the phone on them at all times making sure that the phone is charged at all times." Feel free to call the coverage phone when you have an emergency and you need to contact someone at the school. The number is 773-203-9950. You should not give this number to friends who may call looking for you!

Coverage is a very busy job. They are running up and down the stairs, and of course, must get tired at some point! "All the time!!!" Lisa said. Warren also said, "Sometimes, but not really because there is so much energy in the building and the students will not let you get bored."

Coverage is a huge responsibility! They get to know the students very well and they have a job that they can't slack on. They are here for the students to keep them safe and to make sure that everything in the building is running smoothly. They may get tired, but they are always running around the school taking care of things whether it is unlocking bikes, finding more staff, or getting car keys. They do a lot more than their job description states!

O'School. They plan on taking on these new leadership roles while still managing their current responsibilities. Part of their new responsibilities include attending community meetings and making sure everybody else does their job correctly.

Dr. Roth worked here for about three years, during which time he modified the way in which Staff participates in quarterly meetings and opened up the collaboration process between students and their parents, while also writing two books on the side, according to Diana. Students have also reported him to be the distributor of Christmas gifts when Santa Claus needed a little extra help. "As most of you know, he is a very kind man, and that's probably what we'll all miss the most," Diana explained when questioned about how the O'School community is handling the change involving Dr. Roth.

The responsibilities of the executive director of the school basically involve making sure everybody else in the school is doing their job correctly and maintaining safety within the school twenty-four hours a day, seven days a week. Executive directors of therapeutic schools are in charge of leading staff meetings, admitting new students into the school, making all of the phone calls to the organizations who donate money to the school to see if any more donations are available, and hiring all new employees.

Public schools have a different way of handling themselves. In fact, they don't even have executive directors. Instead, the principal of the public school will take on the role of the executive director by providing instructional leadership and supervising the overall operation of the school's facilities, according to Sharla Brown-Ajayi, the school administration manager of Normal Community High School. Sharla also said that the public schools are only responsible for their students' safety when the students are on the school's property.

Another difference that exists between therapeutic schools and public schools is that principals of a public school have to strictly stick to the Illinois School Code when hired. The Illinois School Code lists all of the qualifications and requirements that a public school principal must have in order to be hired and manage to do their job in an affective manner. The full requirements for becoming a principal are specifically named

in the Illinois School Code, 105 ILCS 5/21 7.1.

The executive director of a therapeutic school, however, must not only follow this code but also have a minimum of 5 years of administrative experience, and an advanced degree in a relevant area of study, according to Diana. Diana also says that executive directors of therapeutic schools get to know families better than public school principals because therapeutic schools involve the student's family in every aspect of their treatment. "Other than that, public schools and therapeutic schools are run pretty much the same," Sharla said.

Diana and Pete insist that in order to transition smoothly into their new jobs, they will consult with the students about new changes to be made, to some extent at least. "Our main concern is the students and their level of happiness," Diana said when questioned about the transitional plans. Pete also insists that the number one priority is maintaining the safety of the students.

The students have been deeply affected by Dr. Roth's decision to resign. As for some of the younger students, they will miss Dr. Roth's appearance as Santa's beloved helper, but some of the older students will miss their ability to have private chats about their issues with Dr. Roth in his office.

"What I'll miss most about him is his mellow sense of humor," Mollie said.

"I'll miss the fact that he stopped everything he was doing to talk to a student the second you asked him," Kelsey Jo said, commenting later on his reliability and the level of trust he built up with the students.

"He also loved his grandma a lot, which I thought was cool," Mollie added when overhearing the question.

Danica insisted that she will miss the ability to be herself around someone she cares deeply about, but added that she's happy for Dr. Roth's new opportunity because he will add a unique flavor to the new job he's accepting.

# Downloading Music Legally

Her mom paid a site a small fee and she was able to download all the music she wanted. The Federal Government sued her for this little mistake. When people download music it may seem very easy to do. On the other hand you must be cautious if you want to avoid downloading music illegally.

Sites like

Lime-wire and iTunes are huge sites where you can download music. Many people use these to download music for their iPod or MP3 player, but there is a difference between itunes and Lime-Wire. Lime-Wire uses file sharing which is illegal when you share copyrighted items. iTunes follows copyright laws, and when you buy the music you must pay money and then a percentage of that money goes to the artist.

File-sharing allows several users to access the same file, giving the user the ability to read, modify, copy or print. Sharing files from peer to peer networks has become a popular way for music lovers to sample and gather music from a wide range of performers, according to cippic.com. The RIAA also knows as Recording Industry American Association, comes down strongly against file sharing, says a report by Ball State University.

On the Lime Wire website, they say that Lime Wire is a fast easy to use "file sharing program" that contains no spyware. Lime-Wire is, however, very well known for causing viruses on people's computers. Other



sites can cause viruses due to file sharing as well because you do not know exactly what is on someone else's computer.

With I-Tunes you can rent and buy movies, purchase songs and sometimes pre-order CD's, as well as purchase TV shows and games that are able to go onto your I-Pod or MP3 player. On I-Tunes people can also make their own podcasts and download them for free, but it is against the terms and conditions to put a song on a podcast because they do not own it.





## Suicide Is Not The Answer

Suicide is the leading cause of death of kids in this country. According to a study that was supervised by Kevin Caruso, a psychologist and founder of a suicide prevention

website, every year 100,000 kids die by suicide while another 100,000 kids try to die by suicide each year but fail. Just so we're on the same page, the number one cause for suicide is untreated depression. Other major causes may include: loss of a loved one, experiencing a traumatic event, abandonment, abuse or divorce.

The truth is that suicide can be prevented if people get help, and what a lot of people don't emphasize enough is that people who are suicidal must get immediate help. Some signs of someone feeling suicidal are refusal to take prescribed medications, lack of interest in former hobbies, lack of hygiene,

fatigue, obsessively thinking about or talking about suicide, isolation from peers, sudden change in appearance, and self-injurious behavior.

If you see someone who appears to be suicidal or you are the one feeling suicidal you can either talk to the suicidal person to offer them support in their time of struggle

or talk to a counselor personally who can offer the right kind of help. You can also encourage people to attend a suicide support group or call a suicide hotline because either way there are trained professionals who know how to handle talking to a suicidal person. The main thing you want to do is make sure they know that you love and care for them because when someone is feeling suicidal they need support then more than ever.

According to several suicide prevention websites for The American Psychological Foundation, and SAFE (Self-Abuse Finally Ends), you can

choose to follow specific guidelines when talking about suicide with others that will ensure that nobody is offended or triggered by your words. First of all, if you feel suicidal, *Continued on Page 11*

do not feel ashamed about seeking help for yourself. Surround yourself with supportive friends and family members, and stay away from people that might be insensitive or hurtful. Remember that you deserve to be treated with the highest level of respect

and sensitivity 100% of the time, and this is not something you should have to remind people of.

Do not hesitate to talk about suicide with others, but please do so in a healthy way that is respectful to suicide survivors and people that are having a hard time dealing with the aftermath of suicide. Do not sensationalize or romanticize suicides or portray them as heroic by saying that a suicide "ended pain" or "ended suffering." Be careful of what you say in regards to saying that someone died by suicide or attempted suicide because if you don't approach this subject with prudence, you might end up offending somebody.

Now that you know how to approach the subject of suicide in speech, let's explore how suicidal ideation is responded to at

the O'School. According to the Starz counselors, when someone here tells one of the counselors they are feeling suicidal, a plan of action is made in regards to their safety. If they are physically threatening to themselves or others to an extreme level, they might be sent to a nearby hospital. If they are not a physical threat to themselves or others, then the plan of action usually begins with a search of the person's area in their dorm. Next they usually have a set of guidelines that the person has to follow, such as the person has to be with Staff at all times or they have to remain in places in the dorm where Staff can see them at all times. After the person calms, the selfsoothing process begins in which methods

of distraction are practiced. Usually when the person is in a calm and rational state of mind, the counselors will talk to them about their feelings.

There are several ways for people who are feeling suicidal to get help. Here at the O'School, we have counselors, therapists, and teachers who can talk to us about how we are feeling. Elsewhere, there are support systems from our hometowns or the national suicide hotlines.




